

INTERNATIONAL COOPERATION AGREEMENT

Riga, 6 May, 2015

SIA Juridiskā koledža (hereinafter -the College of Law), in the person of **Tālavš Jundzis**, Director, as the first party, and Utenos kolegija (hereinafter - the Utena University of Applied Sciences) , in the person of **Gintautas Bužinskas**, Rector, as the second party, henceforward in this text as the Parties,

Appreciative of the need to strengthen and to develop further cooperation in the of education and science,

Desirous of widening opportunities for students from both Parties to study, engage in scholarly study and creative endeavours using the facilities and intellectual resources at the disposal of both Parties

Have agreed the following:

1. The College of Law and Utena University of Applied Sciences confirm their interest in comprehensive cooperation and undertake to facilitate the sharing of student and faculty staff experience with a view to ensuring a high standard of education through participation in conferences organised by the Parties. As well as in their development of methodological materials, to cooperate in the preparation and publication of educational and methodological texts, in realising diverse projects, an otherwise.

2. Based on this agreement on cooperation between the College of Law and Utena University of Applied Sciences in the field of education and research, Utena University of Applied Sciences agrees to accept in its study programmes graduates of the College of Law in the third year of study respecting the general guidelines on registering new students as adopted by the Utena University of Applied Science. The Parties note that at the time of signing this Agreement the following study programmes are relevant and undertake to carry out their detailed comparison:

3. The Parties agree that graduates of the College of Law will be accepted for study at Utena University of Applied Sciences upon detailed comparison of the study programme that had been followed.

4. The College of Law undertakes to inform its students about this Agreement and about details of their possible continued studies at Utena University of Applied Sciences.

5. In the event of the College of Law ceasing to offer all or part of the study programme described in Article 2 (supra), it shall inform Utena University of Applied Sciences who shall adjust the provisions for accepting students for possible study who have graduated from the College of Law.

6. In the event of Utena University of Applied Sciences ceasing to offer all or part of the study programme described in Article 2 (supra), it shall inform the College of Law who in turn shall inform its students.

7. The Parties agree that any costs arising from implementation of this Agreement shall be covered by a separate agreement between the Parties.

8. All disagreements between the Parties that might arise from implementation of this Agreement are to be resolved through negotiation between the Parties. If resolution cannot be reached this, disputes between the Parties are resolved in conformity with national normative acts.

9. This Agreement enters into force at the date of its signature and is concluded for an indefinite period.

10. This Agreement may be revised, supplemented or terminated by mutual agreement of the Parties.

11. This Agreement has been signed in two copies, one held by each Party.
